VACANCIES OCCURRING AMONG THE OFFICERS MAY BE FILLED BY THE BOARD OF DIRECTORS FOR THE UNEXPIRED TERM. THE BOARD OF DIRECTORS MAY REMOVE ANY OFFICER FOR CAUSE AND DECLARE HIS OFFICE VACATED.
